## ARTICLES OF INCORPORATION

SECRETARY OF STATE

We, the undersigned, being three or more natural persons of full age, at least two-thirds of whom are citizens of the United States or of its territories or possessions, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt articles of incorporation as follows:

ARTICLE ONE. The name of the corporation is BUZ FAWCETT'S OUTDOOR WORKSHOPS, INCORPORATED.

ARTICLE TWO. The purposes of the corporation are to engage in the business of year round instruction and training of students in outdoor activities, including, but not limited to, hunting, fishing, boating, skiing, and all other outdoor activities and the incidental services that appertain thereto; to engage in the business of operating a lodge or other facilities for the above purpose and to construct such facilities as are necessary in connection to the same; to engage in the business of selling food and beverages, both alcoholic and nonalcoholic; to sell, trade or manufacture, deal in or deal with goods, wares, and merchandise, and to carry on such business as wholesalers, retailers, importers, and exporters; to acquire such merchandise, supplies, materials, and other articles as shall be necessary or incidental to such business; and to carry on any other lawful business whatsoever in connection with any of the foregoing, or which is calculated directly or indirectly to promote the interests of this corporation, or to in any way enhance the value of this corporation.

ARTICLE THREE. The duration of the corporation is perpetual.

ARTICLE FOUR. The location and post office address of the registered office of the corporation in the State of Idaho is 2805 Starlington Drive, City of Boise, County of Ada, 83712, and the name of its registered agent at such address is W.H. Fawcett.

ARTICLE FIVE. The total authorized number of shares of stock is 100. All of such shares of stock are without par value.

ARTICLE SIX. The number of directors constituting the initial board of directors is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:
