OF THE

Know all Men by These Presents:

That we, the undersigned, a majority of whom are ^{free holders} Citizens and residents of the State of Idaho have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the STATE OF Idaho.

And we Hereby Certify:

FIRST. That the name of said Corporation shall be Treasureton Irrigation Ditch Company
SECOND. That the purposes for which it is formed are To irrigate the arid lands in and about the Precinct of Treasureton and also for domestic purposes

THIRD. That the place where the principal business of said Corporation is to be transacted is Treasureton, Bannock Co. Idaho

FOURTH. That the term for which said Corporation is to exist is Fifty years, from and after the date of its Incorporation.

FIFTH. That the number of Directors or Trustees of said Corporation shall be Five and that the names and residences of the Directors or Trustees, who are appointed for the first year, ^{a majority of the members being present} and to serve until the election and qualification of such officers, are as follows, to wit:
