Additions and amendments 7to Mth Articles of Incorporation of Friends of the Nampa Public Library

Add to Article II the following paragraphs

This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

Notwithstanding any other provisions of the Articles, the corporation shall not carry on any other activities not permitted to be carried out by an organization exempt from Federal income tax under Section 501 (c) (3) of the Code.

This organization is not organized for profit, and no part of the net earnings shall inure to the benefit of any private shareholder.

Amend Article III to read

Upon the winding up and dissolution of this corporation, after paying or providing for the debts and obligations, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which has established its tax exempt status under Section 501 (c) (3) of the Code.
