I, J. D. (CY) PRICE, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

COLI COMMUNITY CHURCH, INC.

was filed in the office of the Secretary of State on the **sixteenth** day
of **July** **A. D. One Thousand Nine Hundred Forty-eight** and
is duly recorded on Film No. **15** of Record of Domestic Corporations of the State of Idaho,
and that the said articles contain the statement of facts required by Sections 29-103, 29-1101 and
29-1102, Idaho Code, Annotated.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates
and successors are hereby constituted a corporation, by the name stated in the articles, and for
50 years' existence from the date hereof, with its registered office in this State located
at **Boise** in the County of **Ada**,
and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service
Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 29,
Idaho Code, Annotated.

ARTICLES OF INCORPORATION OF COLE COMMUNITY CHURCH, Inc.

KNOW ALL MEN, That we the undersigned pursuant to the authority legally vested in us as hereinafter set forth, have this day voluntarily associated ourselves together for the purpose of incorporating under the laws of the State of Idaho, a religious Corporation to be known as Cole Community Church, Inc.

And we certify that the objects for which this corporation is formed are: To establish a church of the Christian Faith in the Cole School Community in Ada County, State of Idaho, for the purpose of Christian Worship, religious training in the Christian Faith, and in general for religious, benevolent and charitable purposes, and not for profit in a material sense.

That the principal place of business of this corporation shall be Boise, Idaho.

That the term of the incorporation shall be fifty years.

That the number of trustees who shall have the custody and management of the church building, estate, property of whatsoever nature, and the affairs of the temporalities thereof shall be five, and the names and the number of years for which each of said trustees was elected are as follows:

R. F. Long, Boise, Idaho, Elected for one year.
J. C. Smithers, Boise, Idaho, Elected for one year.
H. J. Overlin, Boise, Idaho, Elected for two years.
S. C. Coonrod, Boise, Idaho, Elected for two years.
Everett Annan, Boise, Idaho, Elected for three years.

That said trustees were duly elected at a meeting of the members of the Association known as Cole Community Church, duly convened and held at the hour of one o'clock P. M. on the eleventh day of April, 1948, at the Church House of said organization, which said Church House has heretofore been commonly known as Bethany Church, and is located abutting the east boundary line of the public road running north and south along the east side of the Cole School ground, and a short distance south and east of said Cole School, in Ada County, State of Idaho.

That said meeting was held pursuant to a call therefor made by the board of directors of said association, the same being duly and generally publicly proclaimed in the Cole School Community, and especially to the members of said association at the regular meetings of the same prior to said meeting, and also by a notice of said meeting posted on the door of said Church House, the place of said meeting, on the 26th day of March, 1948, which said notice remained so posted until the time of said meeting, which said notice was published once each week for two consecutive weeks prior to said meeting, in the Idaho Pioneer Statewide, a newspaper of general circulation, published weekly in Ada County, State of Idaho, and adjudged and deemed by the directors of said Association as the newspaper most likely to give notice to the greatest number of the members of the Association concerning said meeting and the place and time thereof.

That at said meeting a majority of the members of said Association were present and voted, and it was at said meeting by resolution and vote thereon determined that the board of trustees of the corporation to be organized should be five, and that such board should have complete power in all matters and things relating to the management and control of all of the affairs of said corporation, including the holding of title to real property, and to mortgage, convey and otherwise deal with said real property, all of which is particularly set forth in the certificate and verification by the officer.

CERTIFICATE OF VERIFICATION.

THIS IS TO CERTIFY, That at a meeting of the members of Cole Community Church, duly convened at the church house of said organization, near the Cole School, in Ada County, State of Idaho, on Sunday the 11th day of April, 1948, I, being the Pastor of said organization, was requested to preside over the meeting which I did. A majority of the members of the association were present at the meeting and voted on all questions presented for consideration.

The meeting decided by majority vote that the number of trustees of the organization should be five and that such trustees when elected should proceed to incorporate the organization under the laws of the State of Idaho, the name of the corporation to be Cole Community Church, Inc; and that said trustees should have full power to take charge of and manage the church building, estate, property of whatsoever nature and the temporalities thereof, including the power to hold title to real property and to mortgage, convey and otherwise deal with said real property, and to do all acts and things necessary to be done for the furtherance of the object for which the church is founded as set forth in the articles of incorporation of said church, to which this certificate is attached. Five trustees were elected as set forth in said articles of incorporation, to which said articles reference is hereby made, and by such reference is made a part hereof.

I further state that I have read the articles of incorporation of the Cole Community Church, Inc., to which this certificate is attached, know the contents thereof, and that all the statement of all matters and things therein contained are true, as I verily believe. That E. H. McReynolds was elected in the place of Everett Annan, resigned, and signed these articles. That G. C. Coonrod who signed these articles is the same person as S. C. Coonrod, the initial S. instead of G. being a mistake.


