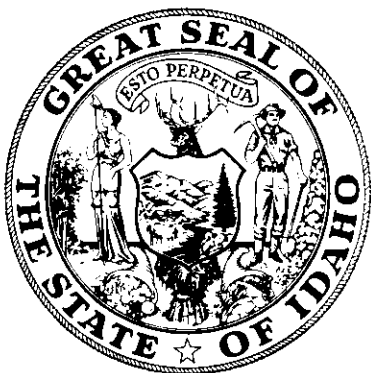

AMENDED AND RESTATED ARTICLES OF INCORPORATION  
OF

PIKE - SAITO & CO., P.A.


1. The name of the Corporation is Jim Pike & Co., P.A.
2. The period of its duration is perpetual.
3. The purpose or purposes for which this Corporation is formed are as follows:
  - (a) To carry on and conduct the practice of accounting under the laws of the State of Idaho through individuals authorized by law to render such services as individuals;
  - (b) Instant to and in furtherance of the above purposes, to invest the Corporation's funds in real estate, mortgages, stocks, bonds, or any other type of investments; and
  - (c) Except as otherwise prohibited by Idaho law, the Corporation, in furtherance of its corporate purposes set forth above, shall have all of the powers necessary and proper for the effectuation of any and all legitimate enterprises of the Corporation, subject to any limitations provided by the laws of the State of Idaho.
4. It shall have authority to issue one hundred (100) shares, all of one class, Ten Dollars (\$10.00) par value.
5. The address of its initial registered office is 25 West Commercial Street, Weiser, Idaho 83672, and the name of its initial registered agent at such address is Carl J. Pike.
6. The number of Directors constituting its initial Board of Directors is two (2), whose names and addresses are:




The undersigned officers of PIKE - SAITO & CO., P.A., duly sworn upon oath, depose and state:
