The name of the corporation is EH CAPA, INC., Articles 13, 15, and 16 of the original Articles of Incorporation are amended to read as follows:

- 13. Number of Directors. The number of directors shall be not less than 5 and not more than 7.
- 15. Powers of Board of Directors. In furtherance and not in limitation of the powers conferred by statute, the Board of Directors is expressly authorized to make, alter, and repeal the bylaws of the corporation.
- 16. Amendments. The Articles of Incorporation may be amended at any regular or special meeting of the voting members of the corporation by a 2/3 vote of the members present in person or by proxy, provided that notice of said amendments stating the substance thereof shall have been mailed to all voting members in good standing at their last known addresses as shown in the records not less than 10 nor more than 50 days before the date of the meeting.

The date of the meeting of members at which the amendment was adopted was February 10, 1990. A quorum was present at such meeting, and the amendment received at least 2/3 of the vote which members present at such meeting in person or by proxy were

entitled to cast. No other classes of members were entitled to vote at the meeting.
