ARTICLES OF INCORPORATION  
OF  
TRANSGLOBAL INTERNATIONAL CORP.



I, the undersigned natural person of the age of twenty-one years or more, acting as incorporator under the Oregon Business Corporation act, adopt the following Articles of Incorporation:

ARTICLE I

The name of the Corporation is Transglobal International Corp. and its duration shall be perpetual.

ARTICLE II

The initial registered office of the Corporation in the State of Oregon is 10580 SW McDonald, Suite 101, Tigard, Oregon 97223, and the initial registered agent for the Corporation is Marty J. Stiles.

ARTICLE III

The purpose and powers of the Corporation are:

1. To engage in any lawful activity for which Corporations may be organized under ORS Chapter 57.
2. To engage in any lawful activity and to do anything in the operation of this Corporation of for the accomplishment of any of its purposes or for the exercise of any power herein set forth which shall appear necessary or beneficial to this Corporation in connection therewith.
