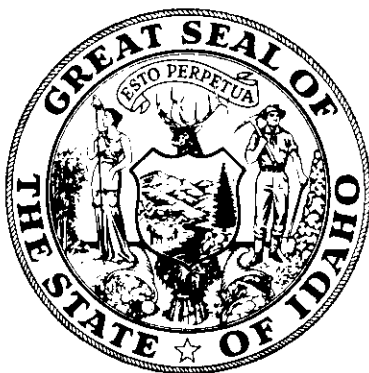

Articles of Incorporation

for

Snake River Software, Inc.

We, the undersigned, natural persons of the age of 21 years or more, acting as incorporators of a Subchapter S of the United States Internal Revenue Code corporation under the laws of the State of Idaho adopt the following articles of incorporation for such corporation:

First: The name of the corporation is Snake River Software, Inc.

Second: The period of its duration is perpetual.

Third: The purpose or purposes for which the corporation is organized are to manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, assign, and transfer, or otherwise dispose of, to invest, trade, deal in and deal with, goods, wares, and merchandise and real and personal property of every class and description., and to perform or provide any service which is not expressly forbidden by law.

Fourth: The aggregate number of shares which the corporation shall have the authority to issue is 100,000 consisting of one class only and having no par value.

Fifth: The corporation will not commence business until at least 3000.00 Dollars have been received by it as consideration for the issuance of shares.

Sixth: Cumulative voting of shares of stock is authorized.

Seventh: There are no provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation.

Eighth: Provisions for the regulation of the internal affairs of the corporation are contained in corporate bylaws.

Ninth: The address of the initial registered office of the corporation is 2100 Belmont Ave., Idaho Falls, Idaho, 83401, and the name of its initial registered agent at such address is Betty J. White.

Tenth: Address of the principle place of business is 2100 Belmont Avenue, Idaho Falls, Idaho 83401.

Eleventh: The number of directors constituting the initial board of directors of the corporation is 4, and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and shall qualify are:
