Pursuant to the provisions of Section 30-1-1007 of the Idaho Business Corporation Act, the undersigned corporation, pursuant to a resolution duly adopted by its board of directors, hereby adopts the following Restated Articles of Incorporation.

These Articles of Incorporation correctly set forth without changing the corresponding provisions of the Articles of Incorporation as theretofore amended and these Restated Articles of Incorporation supercede the original Articles of Incorporation and all amendments thereto.

ARTICLES OF INCORPORATION
OF

I.

The name of the corporation is Rosko Insurance Service, Inc.

II.

The period of duration for this corporation shall be perpetual.

III.

This corporation is formed for the purpose of engaging in the business of soliciting, selling, negotiating and effecting contracts of insurance and to serve the public in good faith as an insurance agent. In addition, said corporation may transact all other lawful business for which a corporation may be incorporated under the laws of the State of Idaho.

IV.

The corporation shall have authority to issue 10,000 shares of stock with no par value.

V.

The name of the registered agent of the corporation is Ross M. Koyle and the address of the registered office is 1270 Santa Anita, Pocatello, Idaho 83201.

VI.

The number of directors constituting the initial board of directors shall be two, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successor or successors are elected and qualified are:






CERTIFICATION OF ROSKO INSURANCE SERVICE, INC.,


