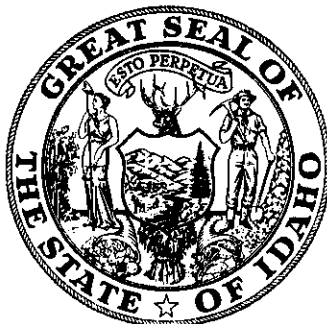
### CERTIFICATE OF AMENDMENT OF

Articles of Amendment to the Articles of Incorporation of IDA-VEND COMPANY are herein executed by said Corporation pursuant to the provisions of Section 30-1-59, et seq., of the Idaho Business Corporation Act, as follows:

1. The name of the Corporation is IDA-VEND COMPANY.
2. The amendment to the Articles of Incorporation of said Corporation is as follows:

ARTICLE IV shall be amended to read as follows:

"The aggregate number of shares which the corporation shall have authority to issue is two hundred thousand (200,000) shares having a par value of One Dollar (1.00) per share."

3. The date of the adoption of said amendment by the shareholders of the Corporation is Dec 8, 1993.

4. The number of shares outstanding of Corporation is ninety thousand one hundred twenty (90,120) shares, all of which are entitled to vote.

5. The number of shares voting for and against said amendment, respectively, were as follows:

For Amendment	90,120 Shares
Against Amendment	0 Shares

6. The amendment does not provide for the exchange, reclassification, or cancellation of issued shares.

7. The amendment does not effect a change in the amount of stated capital of the Corporation.
