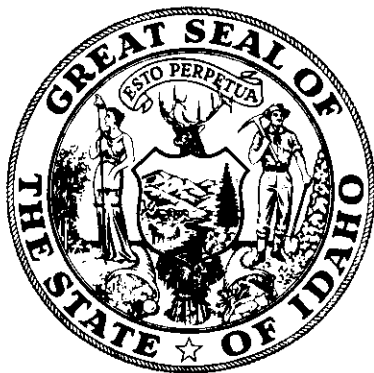

ARTICLES OF INCORPORATION  
OF  
BORGMANN LOGGING, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is BORGMANN LOGGING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: Logging and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 250,000 shares, all of one class, \$1.00 par value.

FIFTH: Provisions denying preemptive rights are: NONE

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: NONE

SEVENTH: The address of the initial registered office of the corporation is Route 2, Box 26 V, St. Maries, Idaho, 83861, and the name of the initial registered agent at such address is BARRY P. BORGMANN.


