## ARTICLES OF INCORPORATION

OF

WINNERS' CIRCLE HORSE PRODUCTS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is WINNERS' CIRCLE HORSE PRODUCTS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) shares of par value of one dollar (\$1.00) each.

FIFTH: Provisions denying preemptive rights are: None.
