
CERTIFICATE OF INCORPORATION OF

Articles of Incorporation

of

Limnion Corporation

The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is Limnion Corporation.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized is to transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The corporation shall have the authority to issue one thousand shares of stock all of one class, and all of such shares shall be without par value.

V.

The address of the initial registered office of the corporation is 19905 Cape Horn Road, Athol, Idaho. The name of the initial registered agent at such address is David Paul Murray. The mailing address of the corporation is Post Office Box 736, Bayview, Idaho 83803.

VI.


