ARTICLES OF INCORPORATION

- 1. NAME: Chiropractic Academy of Homeopathy, Inc.
- 2. STATUS: This corporation shall be a nonprofit corporation governed by the laws of the State of Idaho.
- DURATION: the period of duration shall be perpetual.
- 4. PURPOSE:
 - a) To standardize educational curriculums at chiropractic colleges teaching homeopathy.
 - b) To promote examiniation and certification of practitioners in the speciality of homeopathy.
 - c) To encourage scientific research and publications dealing with the homeopathic speciality.
 - d) To provide standards for continuing education.
 - e) To provide a public relations program for the advancement of the homeopathic speciality withing the chirorpacite profession.
 - f) Other needs relating to the homeopathic speciality as the Board of Directors may see fit to promote from time to time.
 - g) The property of the corporation is irrecocably dedicated to the above stated purposes and upon the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment, of all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational, religious, literary, and/or scientific purposes and which has established its tax exempt status under section 501 (c) (3) of the Internal Revenue Code.
- 5. MEMBERSHIP: This corporation shall have one class of membership; a) Members - Said members shall each hold one vote and have the right to nominate candidates to the Board of Directors and Executives offices.
 - b) Certificates This corporation will issue certificates of membership status. The certificate however, remains the property of the Chiropractic Academy of Homeopathy, Inc., and may be recalled for unprofessional conduct or failure to maintain a compatable degree of proficiency to other certificate holders.
