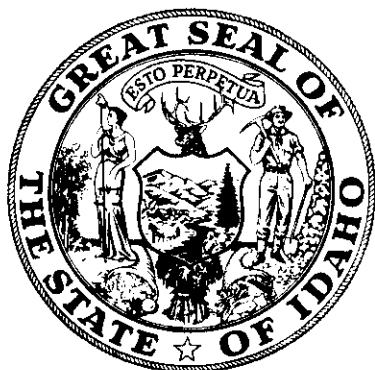

ARTICLES OF INCORPORATION

OF

CHIC-ERY, INC.

1. The name of the corporation is CHIC-ERY, INC.
2. The period of its duration is perpetual.
3. The purpose or purposes for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
4. It shall have the authority to issue four hundred (400) shares of stock, all of one class, of the par value of \$100.00 each.
5. The address of its initial registered office is 301 "A" Street, Idaho Falls, Idaho 83401. The name of its initial registered agent at such address is Cristine V. Hansen.
6. All of the powers of the Board of Directors in the conduct and management of the corporate affairs conferred or imposed upon the Board of Directors by the Idaho Business Corporation Act, Idaho Code §§ 30-1-1 et seq., are assumed by the Shareholders.
7. The Shareholders of the corporation may, from time to time, distribute to themselves out of capital surplus of the corporation a portion of its assets, in cash or property, subject to the following provisions:

(a) No such distribution shall be made at a time when the corporation is insolvent or when such distribution would render the corporation insolvent.



(b) No such distribution shall be made unless it is authorized by the affirmative vote of the holders of a majority of the outstanding shares.

(c) Each such distribution, when made, shall be identified as a distribution from capital surplus and the amount per share disclosed to the Shareholders receiving the same concurrently with the distribution thereof.
