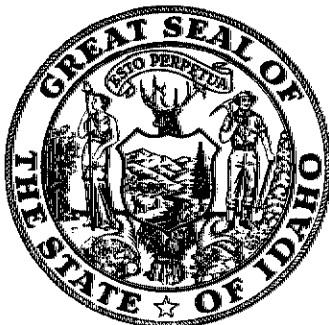

**ARTICLES OF INCORPORATION
OF
HUGHES, INC**

The undersigned, acting as the incorporator of a corporation organized under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I.
NAME**

The name of the corporation is Hughes, Inc.
