

**Articles of Incorporation**  
of  
**AMERICAN TITLE & TRUST COMPANY, (LIMITED).**

**KNOW ALL MEN BY THESE PRESENTS**, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the Laws of the State of Idaho, and we hereby certify

1st. That the name of ~~the~~ said corporation is **American Title & Trust Company, (Limited)**.

2nd: That the purposes for which it is formed are:

- (1) To conduct a general banking business.
- (2) To furnish abstracts of title to real estate; to guarantee the title and to make insurances of every kind pertaining to or connected with titles to real estate, and to make, execute and perfect such and so many contracts, agreements, policies and other instruments as may be required therefor.
- (3) To receive and hold on deposit and in trust and as security, estate real and personal, including the notes, bonds, obligations of States, individuals, companies and corporations, and the same to purchase, collect, adjust and settle, sell and dispose of in any manner, without proceedings in law or equity, and for such price, and on such terms as may be agreed upon between it and the parties contracting with it.
- (4) To act as agent, trustee, assignee, receiver, guardian, executor, administrator, and to take, accept and execute trusts of every description not inconsistent with the laws of this State or of the United States and to receive deposits of money and other personal property and issue its obligations therefor, to invest its funds in and to purchase real and personal securities and to loan money on real and personal securities.
- (5) To act as the fiscal or transfer agent of any State, municipality, body politic or corporation, and in such capacity to receive and distribute money, transfer, register and countersign certificates of stocks, bonds, or other evidences of indebtedness, and to receive and manage any sinking fund therefor on such terms as may be agreed upon.

(6) To take, receive and hold any and all such pieces of real property as may have been or may hereafter be the subject of any insurance made by this Company under the powers conferred by its charter, and the same to grant, bargain, sell, convey and dispose of in any such manner as it sees proper.

(7) To purchase and sell real estate and take charge of the same.

(8) To become security for the payment of all damages that may be assessed and directed to be paid for lands taken in the building of any railway, or for the purpose of any railway, or for opening of streets or roads, or for any purpose whatsoever where land or property is authorized by law to be taken.

(9) To become surety upon any writ of error or appeal, or in any proceeding instituted in any Court in this State, in which security may be required.

(10) To conduct a general trust company business, to loan money, to issue debentures, to buy and sell bonds and commercial paper and to borrow money thereon.

(11) To act as surety on bonds.

3rd: That the place where its principal place of business is to be transacted shall be Pocatello, in the State of Idaho.

4th: The term for which it is to exist is fifty years from and after the date of its incorporation.
