



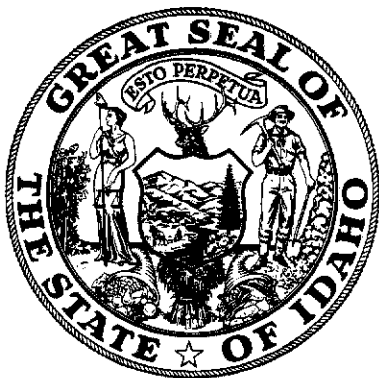
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
AUSTIN TRUCKING, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is AUSTIN TRUCKING, INC. 86 DEC 4 PM 9 55c.

SECOND: The period of its duration is perpetual.

THIRD: Its purpose is to transact the business of a trucking service:

To carry freight for hire; to receive and load all varieties of commercial freight on board highway motor vehicles; to transport such freight to various destinations throughout the United States; and to buy, sell, and otherwise deal in and with tractors and trailers suitable for commercial trucking, and to maintain and repair the same, and to repair and maintain the same; and all other business not forbidden by law.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100 shares, all of one class, no par value. The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than five (5) persons. The stock shall be issued and transferred only to natural persons who are not non-resident aliens.

FIFTH: The address of the initial registered office of the corporation is P.O.Box 402, Salmon, Idaho 83467, and the name of its initial registered agent is Richard W. Austin at Highway 93 South, Salmon, Idaho.

SIXTH: The number of Directors constituting the initial Board of Directors of the corporation is two, and the names and addresses of the persons who are to serve as Directors until the first annual meeting of Shareholders or until their successors are elected and shall qualify are:
