Come now the President and Secretary of the above named corporation who execute in duplicate their Articles of Amendment and who set forth the following:

(a) That the name of the corporation is NORTHWEST COMMUNICATIONS, INC..

(b) That the amendment to the said corporation's Articles of Incorporation adopted pursuant to the Idaho Business Corporation Act of said corporation is as follows:

ARTICLE V

That the corporation shall have authority to issue FIVE HUNDRED THOUSAND (500,000) shares, all one class, of common stock with a par value of \$1.00 per share.

(c) That the date of the adoption of this amendment by the shareholders of this corporation was the 12th day of February, 1988.


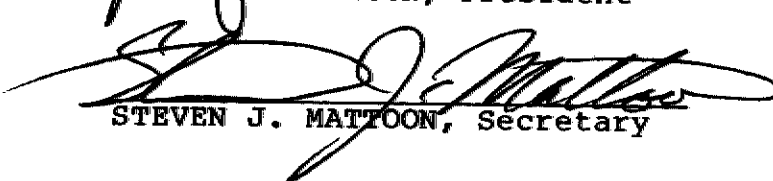
(d) That the number of shares outstanding at the time of the vote of the adoption of said resolution has 150,000 with none entitled to vote as a class.

(e) That the number of shares voting for said amendment was 150,000 with none voting against.

(f) That these amended articles do not provide for an exchange, reclassification or cancellation of issued shares.

(g) That the stated capital is changed as follows: if all shares authorized by the amendment are issued, then the stated capital of the corporation increases from \$150,000 to

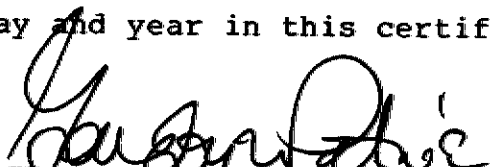
