
ARTICLES OF INCORPORATION OF FRIENDS OF FULBRIGHT IN NEPAL, INC.



Pursuant to the provisions of the Idaho Nonprofit Corporation Act at Title 30, Chapter 3 et. seq. of the Idaho Code:

- 1. The name of this corporation is:
 - Friends of Fulbright in Nepal, Inc. (hereinafter, this "Corporation")
- 2. All of the purposes of this Corporation shall be "exempt purposes" permitted by Section 501(c)(3) of the United States Internal Revenue Code. The exempt purposes of this Corporation shall include but will not be limited to: Assisting scholars visiting Nepal from the United States in conjunction with the United States Educational Program in Nepal; assisting scholars visiting the United States from Nepal; the transaction of other lawful religious, charitable, scientific, literary, and educational activities not inconsistent with Section 501(c)(3) of the United States Internal Revenue Code.
 - 3. This Corporation is not organized for pecuniary gain or profit.
 - 4. This Corporation will:
- a. Promote, encourage, foster, and aid scholars from the United States to receive education in Nepal;
- b. promote, encourage, foster, and aid scholars from Nepal to receive education in the United States;
- c. provide for the collection and administration of monetary contributions to this

- d. provide for the distribution of scholarships and educational aid generated by this Corporation to qualified applicants in conjunction with its scholarship-distributing functions;
- e. promote, encourage, foster, and aid in the creation of goodwill between the nations of Nepal and the United States in furtherance of its lawful religious, charitable, scientific, literary, and educational activities not inconsistent with Section 501(c)(3) of the United States Internal Revenue Code;
- f. engage in any other lawful religious, charitable, scientific, literary, and educational activities consistent with its purposes, as described supra, and lawful, pursuant to the Idaho Code, provided that this Corporation shall never carry on activities inconsistent with Section 501(c)(3) of the United States Internal Revenue Code.

- 7. This Corporation will have members whose powers and responsibilities shall be defined in the by-laws of this Corporation.
- 8. The existing directors of this Corporation will elect the successive directors in accordance with the by-laws of this Corporation. The by-laws shall specify the number of corporate directors and may vest the authority to choose directors in the members of the corporation.
- 9. Upon dissolution of this Corporation for any reason whatsoever, the directors of this Corporation shall distribute all assets existing after payment, discharge, and disposition of all corporate debts, obligations, and liabilities to one or more of the following: An entity or entities qualifying for tax-exempt status pursuant to Section 501(c)(3) of the United States Internal Revenue Code for tax-exempt purposes; the State of Idaho for public purposes; or the United States for public purposes.
 - 10. The incorporator of this Corporation is:
