

CERTIFICATE OF LIMITED PARTNERSHIP OF

The undersigned, having formed a limited partnership, certify as follows and in accordance with Idaho Code Section 53-202:

1. The name of the partnership is BOISE EQUIPMENT COMPANY.

2. The character of the partnership's business is to purchase, hold and use in any manner any property it may acquire and generally to perform any act which in the judgment of the general partners shall be necessary, proper or conducive to the best interest of the limited partnership's ownership, management, operation and use of said property.

3. The principal place of business of the limited partnership is Boise, Idaho, with the mailing address of Post Office Box 8358, Boise, Idaho 83707.

5. The term for which the partnership is to exist is 30 years, commencing January 27, 1982, unless sooner terminated in accordance with the provisions of the partnership agreement.

6. The amount of cash contributed by each limited partner to the partnership with respect to his or her limited partnership interest is \$0 dollars. However, each limited partner is incurring an obligation in order to capitalize the partnership.


7. No additional capital contributions have been agreed upon by the limited partners. The share of profits which each partner shall receive by reason of his or her contribution to capital is in accordance with the following:




