ARTICLES OF INCORPORATION RELARY OF STATE

KNOW ALL MEN BY THESE PRESENTS, That I, the undersigned being a natural person of full age and citizen of the United States, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the Idaho Business Corporation Act and the acts amendatory thereto and supplemental thereto, do hereby certify as follows:

FIRST

The name of the corporation is FIRST PACIFIC FINANCIAL COMPANY.

SECOND

The purposes for which the corporation is organized are to conduct and carry on the business of a real estate mortgage broker and on the basis of the commission or otherwise to act as a real estate loan broker and generally do everything suitable, proper and condusive to the successful conduct of a real estate brokerage business in all of its branches and departments.

THIRD

The corporation is to have perpetual existence.

FOURTH

The location and post office address of the registered office of the corporation is 2607 Kootenai Plaza, Boise, Idaho. The name of the registered agent at such address is Richard E. Weston.

FIFTH

The amount of the capital stock of this corporation is \$114,000.00, divided into 114,000 equal shares of \$1.00 par value.

SIXTH

The private property of the stockholders of the corporation shall not be subject to the payment of corporate debts to any extent whatever, and the shares of the corporation shall not be subject to assessment for the purposes of paying expenses, conducting business, or paying debts of the corporation.
