ARTICLES OF INCORPORATION

of

PINEWOOD MANOR, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, DONALD E. MORRIS, AUGUST STETNER and ROBERT R. BAKER, all of whom are of legal age and citizens of the United States, have this day associated ourselves and do hereby and by these Articles of Incorporation unite and associate ourselves for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby acknowledge, enter into, and adopt the following Articles of Incorporation.

ARTICLE I.

The name of this Corporation shall be PINEWOOD MANOR, INC.

ARTICLE II.

The period of the duration of this Corporation shall be perpetual. $ARTICLE \ III. \\$

The place of business of this Corporation is Coeur d'Alene, Kootenai County, Idaho, and the Post Office Address of its registered office in the State of Idaho shall be 2514 N. Seventh Street, Coeur d'Alene, Idaho.

ARTICLE IV.

In furtherance and not in limitation of the general powers conferred by the laws of the State of Idaho, this Corporation shall have the following purposes and powers:

- 1. To establish and maintain for pecuniary profit in the City of Coeur d'Alene, County of Kootenai, State of Idaho, or elsewhere, a sanitarioum or nursing home, including suitable apartments, offices, parlors, restaurants, and other facilities and conveniences for patients and private patients of physicians, surgeons, and others, and where such patients may receive any medical, surgical, or other treatment, board, lodging, care, and nursing and hygienic treatment.
- 2. To engage in any business whatsoever, either as principal or as agent or both, or as a syndicate, which the Corporation may deem convenient or proper in furtherance of any of the purposes herein mentioned or otherwise; to conduct its business in this state, in other states, in the District of Columbia, in the territories and possessions of the United States, and in foreign countries; and to have and to exercise all powers authorized by the laws of the State of Idaho under which the Corporation is formed, whether expressly set forth in this paragraph or not, as such laws are now in effect or may at any time hereafter be amended.
- 3. To receive, acquire, hold, pledge, transfer, or otherwise dispose of shares of the Corporation.

The foregoing provisions of this Article IV shall be construed both as purposes and powers and each as an individual purpose and power in furtherance of, and not in limitation of, the powers which the Corporation may have under present or future laws of the State of Idaho.

ARTICLE V.

The total capital stock of this Corporation is Ten Thousand (\$10,000.00) Dollars consisting of One Hundred (100) shares of common stock of the par value of One Hundred (\$100.00) Dollars per share. There shall be only one (1) class of stock, common stock, and each share of stock shall be equal and non-assessable.

Any and all of the stockholders of this Corporation may from time to time enter into such agreements as may seem expedient to them, relating to the shares of stock held by them, and limiting the transferrability thereof and thereafter any transfer of said shares shall be made in accordance with the terms of said agreement, provided that before the actual transfer of said shares on the books of the Corporation, written notice of such agreement shall be given to this Corporation by filing a copy thereof with the Secretary of the Corporation, and a reference to such agreement shall be stamped, written, or printed upon the certificate representing such shares, and the by-laws of this Corporation shall likewise include proper provisions for the making of such agreements as

ARTICLE VI.

The power to repeal and amend the corporate by-laws and the adoption of new by-laws is conferred upon the Board of Directors. Any by-laws so amended or adopted may be altered or repealed either by a two-thirds vote of the Board of Directors or by vote of two-thirds of the allotted shares of capital stock.

ARTICLE VII.
