
**CERTIFICATE OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

I. NAME

The name of the corporation is BRIDGE & ASSOCIATES I, INC.

II. DURATION

The corporation shall conduct business in perpetuity or until dissolved.

III. PURPOSE

The purpose or purposes for which this corporation is organized are to operate a property tax evaluation business and related services and any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.






