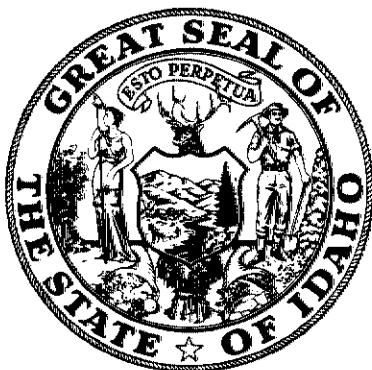

ARTICLES OF INCORPORATION

I

The name of this corporation is VINEYARD CHRISTIAN FELLOWSHIP OF BOISE, INC.

II

This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law primarily for religious purposes. More specifically, the purpose of this corporation is to operate a church for the worship of Jesus Christ.

III

The period of duration is perpetual.

IV

All members of this corporation shall serve on the Board of Directors.

V

VIII

(A) The property of this corporation is irrevocably dedicated to religious purposes, and no part of the net income or assets of this organization shall ever inure to the benefit of a director, officer, or member of the corporation, or to the benefit of any private individual.

(B) Upon the dissolution and winding up of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation organized and operated exclusively for religious purposes and that has established its tax-exempt status under Internal Revenue Code Section 501(c)(3).

IX

(A) This corporation is organized exclusively for religious purposes within the meaning of Internal Revenue Code Section 501(c)(3). Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities, not permitted to be carried on (1) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), or (2) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

(B) No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for political office.
