## ARTICLES OF INCORPORATION

OF

SECRETARY OF

SINCLAIRE MINE RESOURCES, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SINCLAIRE MINE RESOURCES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the ownership, leasing, development and operation of mining properties and mines and the transaction of any and all other lawful businesses for which corporations may be incorporated under the Idaho Business Corporations Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is fifty thousand (50,000) shares of common stock, all of the same class, each having a par value of one dollar (\$1.00).
