The undersigned, Wilbur G. Stover, Jr. and Larry L. Grant hereby declare that (1) they are the Vice President of Finance and Secretary of Micron Semiconductor, Inc. (the "Company"), respectively; (2) that the original Articles of Incorporation of the Company were filed with the Secretary of State of the State of Idaho on July 30, 1992; (3) that there are 171,629 shares of the Company's common stock outstanding and entitled to vote respecting an amendment to the Company's Articles of Incorporation; and (4) that the following amendment to the Company's Articles of Incorporation was approved by unanimous shareholder vote as of January 20, 1993.

Authorized Shares:

1. Article IV of the Company's Articles of Incorporation shall be amended to read in its entirety as follows:

"ARTICLE IV

The aggregate number of shares the corporation shall have authority to issue is ten million (10,000,000) shares of \$0.10 par value per share common stock."
