ARTICLES OF INCORPORATION

STATE

OF

WEISER RACQUET BALL CLUB, INC.

A NON-PROFIT CORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, adopts the following Articles of Incorporation for such Corporation:

FIRST: The name of the corporation is WEISER RACQUET BALL CLUB, INC.

> The period of its duration is perpetual. SECOND:

THIRD: The purpose or purposes for which the corporation is organized are:

- To provide for the mutual assistance, enjoyment entertainment and improvement of its members socially and physically by encouraging them in participation of some form of athletics or physical recreation, including but not limited to the sport of racquet ball, without pecuniary gain or profit, incidental or otherwise, to its members, and to that end:
 - take, accept, hold and acquire by (a) To bequest, devise, gift, purchase, loan, or lease any property, real, personal or mixed, whether tangible or intangible, without limitation as to kind, amount or value.
 - To sell, convey, lease or make loans, (b) grants or pledges of any such property, or any interest therein or proceeds therefrom, and to invest and reinvest the principal thereof and receipts therefrom, if any.
 - To borrow money upon and pledge or mortgage any such property for any purpose for which it is organized and to issue notes, bonds, or other forms of indebtedness to secure any of its obligations.
 - To aid and assist in clearing, rebuilding and rehabilitating blighted, deteriorated (d) areas or structures.
 - To guarantee undertakings, contracts, or (e) performances of others.

(f) To hold, improve by construction or otherwise, develop, clear, prepare, and dispose of real property.

- (g) To carry on any of the foregoing activities or purposes either directly, or as agent for or with other persons, associations or corporations.
- (h) To carry on any activity and to deal with and expend any such property or income therefrom for any of the foregoing purposes without limitation, except such limitations, if any, as may be con-tained in the instrument under which such property is received, the Certificate of Incorporation, the ByLaws of the Corporation, or any other or any other limitations as are prescribed by law, provided that no such activity shall be such as is not permitted by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code or any corresponding future provision of the Revenue Code, and that the Corporation shall not attempt to influence legislation by propoganda or otherwise, or shall it intervene in, or participate in, any political campaign on behalf of any candidate for public office, and provided further that no part of the net earnings of this Corporation shall innure to the benefit of any member or private individual and no member, director, or officer of the Corporation shall receive any pecuniary benefit from the Corporation, except such reasonable compensation as may be allowed for services actually rendered to the Corporation.

FOURTH: The aggregate number of shares this Corporation shall have authority to issue is FIFTY (50) shares of common stock.

FIFTH: The address of the initial registered office of the Corporation is 517 East Liberty Street, Weiser, Idaho 83672, and the name of its initial registered agent at such Address is BOB TAISEY.

SIXTH: <u>Initial Directors</u>: The names and addresses of those persons who are to act as Directors until the election of their successors, and who shall be subject to all of the provisions of the aforementioned Act relating to Directors, and who shall constitute the number of Directors of the Corporation until changed by the By-Laws, are:
