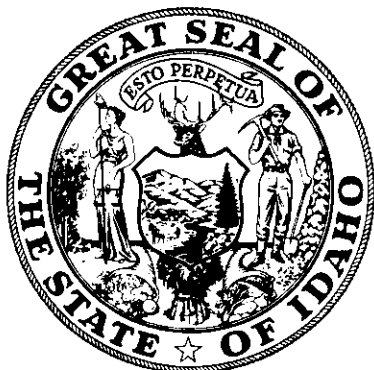

6 A NON-PROFIT CORPORATION

7 The undersigned, acting as incorporators of a corporation
8 under the Idaho Non-Profit Corporation Act, adopts the following
9 Articles of Incorporation for such Corporation:

10 FIRST: The name of the corporation is WEISER RACQUET
11 BALL CLUB, INC.

12 SECOND: The period of its duration is perpetual.

13 THIRD: The purpose or purposes for which the corporation
14 is organized are:

15 (1) To provide for the mutual assistance, enjoyment
16 entertainment and improvement of its members
17 socially and physically by encouraging them in
18 participation of some form of athletics or
19 physical recreation, including but not limited
20 to the sport of racquet ball, without pecuniary
21 gain or profit, incidental or otherwise, to its
22 members, and to that end:

23 (a) To take, accept, hold and acquire by
24 bequest, devise, gift, purchase, loan,
25 or lease any property, real, personal or
26 mixed, whether tangible or intangible,
27 without limitation as to kind, amount or
28 value.

29 (b) To sell, convey, lease or make loans,
30 grants or pledges of any such property,
31 or any interest therein or proceeds
32 therefrom, and to invest and reinvest the
principal thereof and receipts therefrom,
if any.

(c) To borrow money upon and pledge or mort-
gage any such property for any purpose for
which it is organized and to issue notes,
bonds, or other forms of indebtedness to
secure any of its obligations.

(d) To aid and assist in clearing, rebuilding
and rehabilitating blighted, deteriorated
areas or structures.

(e) To guarantee undertakings, contracts, or
performances of others.

- 1 (f) To hold, improve by construction or other-
2 wise, develop, clear, prepare, and dispose of
3 real property.
- 4 (g) To carry on any of the foregoing activities or
5 purposes either directly, or as agent for or with
6 other persons, associations or corporations.
- 7 (h) To carry on any activity and to deal with and
8 expend any such property or income therefrom for
9 any of the foregoing purposes without limitation,
10 except such limitations, if any, as may be con-
11 tained in the instrument under which such property
12 is received, the Certificate of Incorporation,
13 the ByLaws of the Corporation, or any other
14 or any other limitations as are prescribed by
15 law, provided that no such activity shall
16 be such as is not permitted by a corporation
17 exempt from Federal Income Tax under Section
18 501(c)(3) of the Internal Revenue Code of 1954
19 or any corresponding future provision of the
20 Revenue Code, and that the Corporation shall
21 not attempt to influence legislation by propo-
22 ganda or otherwise, or shall it intervene in,
23 or participate in, any political campaign on
24 behalf of any candidate for public office, and
25 provided further that no part of the net
26 earnings of this Corporation shall inure to
27 the benefit of any member or private individual
28 and no member, director, or officer of the
29 Corporation shall receive any pecuniary benefit
30 from the Corporation, except such reasonable
31 compensation as may be allowed for services
32 actually rendered to the Corporation.

19 FOURTH: The aggregate number of shares this Corporation
20 shall have authority to issue is FIFTY (50) shares of common
21 stock.

22 FIFTH: The address of the initial registered office of
23 the Corporation is 517 East Liberty Street, Weiser, Idaho 83672,
24 and the name of its initial registered agent at such Address is
25 BOB TAISEY.

26 SIXTH; Initial Directors: The names and addresses of
27 those persons who are to act as Directors until the election of
28 their successors, and who shall be subject to all of the provisions
29 of the aforementioned Act relating to Directors, and who shall
30 constitute the number of Directors of the Corporation until
31 changed by the By-Laws, are:
