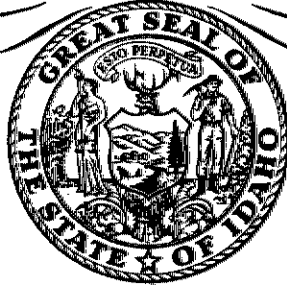

CERTIFICATE OF INCORPORATION

I, PETE T. CENARRUSA, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

CHURCH OF JESUS CHRIST, CHRISTIAN OF HAYDEN LAKE

was filed in the office of the Secretary of State on the 19th day of September A. D. One Thousand Nine Hundred seventy-five and ^{to be} is duly recorded on Film No. microfilm of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **Perpetual Existence** from the date hereof, with its registered office in this State located at Hayden Lake, Idaho in the County of Kootenai and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION OF CHRUCH OF JESUS CHRIST, CHRISTIAN
OF HAYDEN LAKE

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day volantly associated ourselves together for the purpose of forming a corporation under Chapter Eleven Title 30, Idaho code.

ARTICLE ONE: That the name of this corporation shall be

"CHRUCH OF JESUS CHRIST, CHRISTIAN OF HAYDEN LAKE"

ARTICLE TWO: This Corporation existance shall be perpetual. That this corporation does not contemplate the distribution of gains, profits or dividends to the members thereof.

ARTICLE THREE: That the principal office for the transaction of the business of this corporation shall be located in Hayden Lake, County of Kootenai, State of Idaho.

ARTICLE FOUR: That the purposes for which this corporation is formed are as follows;

(A) To propagate the Christian religion and the revealed laws and purposes of God, as revealed in the Holy Bible; to study, interpret, teach explain and expound the prophecies set forth in the Holy Bible, and their fulfillment, past, present and prospective, as shown by the Scriptures, the facts of history, and contemporary laws, together with other corroborative evidence thereof; to teach explain the Christian duty to obey the laws of God and the warnings of the prophets, as given in the Holy Bible, directed to those who live in these Latter Days.

(B) To organise, create and incorporate subordinate groups or congregations in various counties, cities, towns, villages and communities, within and without the State of Idaho; to adopt, prescribe, amend, enforce and repeal rules and regulations for the decission, government and discipline of said groups and congregations in matters pertaining to the religious activities thereof, and to prescribe, adopt, amend, enforce and repeal rules and regulations for the discipline, disincorporation and expulaion of said groups or congregations and/or the members thereof; all of said rules and regulations may be adopted, amended or repealed

thereof; all of said rules and regulations may be adopted, amended or repealed by the Directors of this corporation, as part of the By-Laws.

(C) To acquire real and personal property of every kind and nature, by purchase, exchange, loan, gift, devise, bequest, lease, or otherwise; and to take, keep, hold possess, use, loan, lease, sell, exchange, transfer, mortgage, hypothecate or otherwise dispose of the said property in any lawful manner and for any purpose, in furtherance of the objects of this Corporation.

(D) To ordain ministers of the Church, and prescribe the qualifications thereof; to adopt, amend enforce and repeal regulations concerning the conduct of said ministers in their activities as such in all acts and activities which may reflect upon the reputation of said ministers and/or the corporation or its subordinate congregations, and to discipline or expel said ministers for violations of any of said regulations.

(E) To employ ministers, teachers, lecturers, writers, and other agents, servants and employees; to purchase, make, produce print exhibit, sell, lend, lease, give away or distribute books pamphlets, tracts, photographs and other pictures, moving picture films and other representation to the eye, phonographic and other records and transcriptions, radio and television broadcasts; to establish, acquire and maintain schools, seminaries, colleges and institutions of learning; to provide instructors, books and other materials for study and use in institutions of learning maintained by others.

(F) To exercise any and all lawful powers and privileges now or hereafter granted by the laws of the State of Idaho to non-profit corporations, in furtherance of the foregoing purposes, both within and without the State of Idaho.

ARTICLE FIVE: The number of Directors of this corporation shall be ^{five}~~three~~, until changed by provision made in the By-Laws for a different number. The following named persons shall act in the capacity of Directors of the Corporation until the




