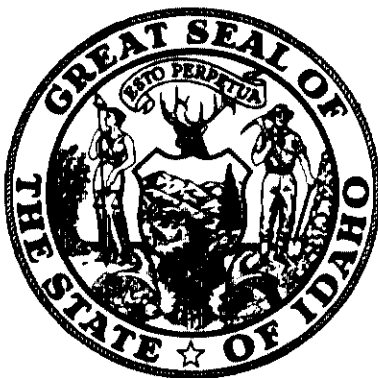
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

of

We, the undersigned, natural persons over the age of eighteen years of age, acting as incorporators of a corporation under the laws of the State of Idaho, adopt the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of the corporation is THE MAIN DRAIN, INC.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purpose for which the Corporation is organized is to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares of common stock at a par value of no par .

ARTICLE V.

The corporation will not commence business until at least Five Hundred Dollars (\$500.00) have been received by it as consideration for the issuance of shares.

ARTICLE VI.

Cumulative voting of shares of stock is authorized.

ARTICLE VII.

There are no provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation.

ARTICLE VIII.

Provisions for the regulation of the internal affairs of the corporation shall be as set forth in the Bylaws of the corporation.

ARTICLE IX.

The address of the initial registered office of the corporation is HCR 60, Box 273, Bonners Ferry, Idaho 83805, and the name of its initial registered agent at such address is MERLE D. BROWN.

ARTICLE X.

The address of the principal place of business is 315 Chinook Road, Bonners Ferry, Idaho 83805.

ARTICLE XI.

The number of directors constituting the initial board of directors of the corporation is four (4), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
