ARTICLES OF INCORPORATION

OF

LAW ENFORCEMENT SUPPORTERS, INC.

The undersigned, acting as the incorporator of a nonprofit corporation ("Corporation") organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idino Code ("Act"), adopts the following Articles of Incorporation for the Corporation.

- I. Name of Corporation: The name of the Corporation is Law Enforcement Supporters, Inc.
- II. Nonprofit Status: The Corporation is a nonprofit corporation.

- III. Period of Duration: The period of duration of the Corporation is perpetual.
- IV. Registered Agent and address: The address of the corporation's initial registered office is 355 W. Myrtle #102, Boise, Idaho 83702. The name of its official registered agent at such address is Robert C. Montgomery, Chtd.
- V. **Purposes**: The purposes for which the Corporation is organized and will be operated are as follows:
 - A. The Corporation will promote support for local law enforcement.
 - B. Charitable, religious, educational, or scientific within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under such Section 501(c)(3).
 - C. To exercise all powers granted by law necessary and proper to carry out the abovestated purposes, including but not limited to the power to accept donations of money, property, whether real or personal, or any other thing of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Act, or any amendment thereto or substitute therefor, may not at the time lawfully carry on or do.
- VI. Limitations: No part of the net earnings or the assets of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof. No substantial part of the

activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time.

- VII. Members: The Corporation shall have members who shall have such rights as are provided in the Act and are consistent with provisions of these articles. A person may become a member of the Corporation upon payment of the annual dues fixed by the Board of Directors, if any, and upon approval by the Board of Directors.
- VIII. Board of Directors: The affairs of the Corporation shall be managed by its Board of Directors. The Board of Directors shall consist of not less than three (3) nor more than seven (7) individuals, each of whom, at all times, shall be a member of the Corporation. The actual number of Directors shall be fixed by the Bylaws of the Corporation. Other than the Directors constituting the initial Board of Directors, who are designated in these Articles, the Directors shall be elected or appointed by the existing Directors in the mnner and for the term provided in the Bylaws of the Corporation.

- IX. Incorporator: The name and street address of the incorporator is: Robert C. Montgomery, 355 W. Myrtle #102, Boise, Idaho 83702.
- X. Bylaws: Provisions for the regulation of the internal affairs of the Corporation shall be set forth in the Bylaws.
- XI. Membership Dues: Membership dues may be charged to all members or classes of membership in equal amounts or in different amounts or proportions upon different members or classes of membership and some members or classes of membership may be made exempt from such membership dues. The Board of Directors is authorized to fix

the amount of membership dues from time to time, and to make them payable at such times or intervals, and upon such notice, and by such methods as the Board of Directors may prescribe.

XII. Distribution on Dissolution: Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute all the assets of the Corporation consistent with the purposes of the Corporation to such organization or organizations as shall at the time qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, in such manner as the Board of Directors shall determine Any such assets not so distributed shall be distributed by the district court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations, as such court shall determine to be consistent with the purposes of the Corporation.
