ARTICLES OF INCORPORATION OF CAMAS CIVIC ORGANIZATION, INC.

ARTICLE I.

Section 1. This corporation shall be called the Camas Civic Organization, INC.

Section 2. This corporation shall be a non-profit corporation organized under the laws of the State of Idaho for non-profit corporations as set forth in Title 30, Chapter 3.

Section 3. This corporation shall have a perpetual existence.

Section 4. The object and purpose of this corporation shall be to promote responsible growth of Camas County, promote the general welfare of the citizens of Camas County, create civic pride in the citizens of Camas County, encourage other civic community groups of Camas County, educate the general public of the attributes of Camas County, enrich the lives of the youth of Camas County, improve the climate for economic growth in Camas County and to encourage recreation within Camas County.

ARTICLE II.

Section 1. The membership of this corporation shall consist of any resident of Camas County or person interested in Camas County who pays dues as established by the Board of Directors.

Section 2. The initial registered office of the corporation shall be C/O Camas Grain, P. O. Box 337, Soldier Road, Fairfield, ID 83327.

Section 3. The initial registered agent of the corporation is Linda Miller.

Section 4. The following constitutes the names and addresses of the initial Board of Directors.

ARTICLE III.

The Board of Directors of this organization shall consist of five (5) persons. The following constitutes the names and addresses of the initial board of directors:

ARTICLE IV.

All amendments to these articles shall be made under the requirements of Idaho Code 30-325, 30-326, and 30-327.

ARTICLE V.

This association shall be governed and operated through and by the board of directors, and/or the members of this corporation in accordance with a set of by-laws hereinafter to be adopted, which said by-laws shall be in harmony with these Articles of Incorporation and/or the laws of the State of Idaho. The by-laws must be approved before they become effective by a 2/3 vote of the membership present at the corporation organization meeting.

ARTICLE VI.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permited to be carried on by a corporation regulated for tax exempt or other purposes by provisions of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) if this corporation is required by its action or otherwise to come under specific provisions of the Internal Revenue Service Codes this corporation will comply with all rules and regulations required of it by Internal Revenue Rules and Regulations to which it may be subject.

ARTICLE VII.

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining

assets shall be distributed to a nonprofit fund, foundation, or corporation. No member, officer or advisor may receive assets from this corporation except as required as compensation for daily performed services.
