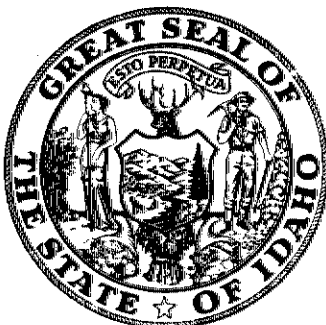

ARTICLES OF AMENDMENT
of

Know all men by these presents that we, the undersigned being the shareholders of Ron Moss, Architect, P.A., respectfully show that:

1. That the above-named corporation was organized under the laws of the State of Idaho on the First day of December, 1994.
2. That the name of the corporation is Ron Moss, Architect, P.A., an Idaho corporation.
