ARTICLES OF INCORPORATION

CLEARWATER COUNTY SENIOR CITIZENS, INC.

BE IT WITNESSES BY THESE PRESENTS that we, the undersigned, being desirous of forming a non-profit corporation for the purposes hereinafter specified in conformity with Section 30-1001, Idaho Code, do make and subscribe the following Articles of Incorporation in triplicate.

ARTICLE I.

NAME

The name of this corporation shall be CLEARWATER COUNTY SENIOR CITIZENS, INC.

ARTICLE II.

PURPOSES

The purposes for which this corporation are formed are and shall be:

To provide a new involvement in community life of people within the senior citizens age group; to provide a resource of information for all senior citizens; to provide a centralized meeting place where senior citizens can relax and enjoy life and exchange news; to provide social and recreational and educational facilities on a non-sectarian and non-partisan basis for all senior citizens; to help each other and better their community; to do and transact any and all business necessary and expedient for carrying out the purposes for which this corporation is formed; to enter into agreements, contracts, purchases, sales and other agreements relating to real and personal property not prohibited by law, necessary and expedient for the purposes of this corporation; to hold

real and personal property and provide by lease, purchase, contract or agreement means of travel, transportation, accommodations, lodgings, food and any other need of its members, at home or abroad, and to do anything not prohibited by law, necessary or requisite for the furthering of the purposes of this corporation.

ARTICLE III.

MEMBERSHIP

This corporation shall have no capital stock but shall issue membership certificates to each member and all the rights and interest of each member shall be equal and no member may have or acquire a greater interest than any other member therein. Such memberships cannot be assigned or transferred so that by such transfer the transferee may become a member of the corporation except by resolution of the board of directors under such regulations as may be prescribed by the by-laws. No person may become a member who has not attained the age of fifty-five years and falls within the age limits of senior citizens.

ARTICLE IV.

TERM OF EXISTENCE

The term of existence of this corporation shall be perpetual.

ARTICLE V.

DIRECTORS

This corporation shall have 8 directors who shall at all times be citizens of the United States and the names and residences of said directors who shall manage the business of the corporation until the first meeting are:
