and a connecting branch line from MASON IN Paradise Valley, Newada, to

WINNEAUCCA Newada.

- II. The estimated length of this line of Railway, branch line and Telegraph Line is 1000 miles.
- III. To Build, Own, Equip and Operate such branch lines as may be necessary to aid, promote and serve the interests of its main line of Railway.
- IV. To acquire by Purchase, Lease, or otherwise, the Thile, Ownership, Use or Control of such other lines of Railway as may be necessary to perfect its main system.
