ARTICLES OF INCORPORATION

OF

SERVICE TECH INC.

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is Service Tech Inc. (hereafter "Corporation").

ARTICLE II

The purpose of which this Corporation is organized are as follows:

1. To engage in Retail and Wholesale sales and repair;
- and
2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation shall have perpetual existence.

#### ARTICLE IV

The address of the initial registered office of the Corporation shall be 10621 Winterhawk Drive, Boise, Idaho, and the name of its initial registered agent at such address is Vancha May Vizenor.

#### ARTICLE V
