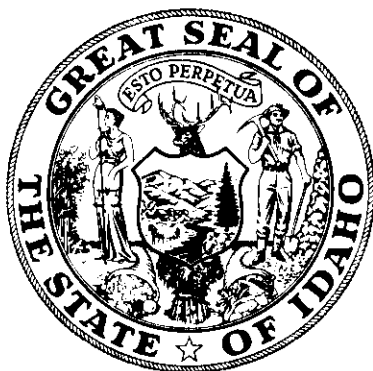

ARTICLES OF INCORPORATION
SECRETARY OF STATE

FOR

LAND and SEA, INC.

We, the following persons, being all capable of contracting and being of legal age, do hereby subscribe to these articles of incorporation for the purpose of forming a corporation under the laws of the State of Idaho, and do hereby certify as follows:

I.

The name of this corporation shall be Land and Sea, Inc.

II.

The business purpose of this corporation shall be the general conduct of the trucking business.

III.

To further conduct such business this corporation shall, as necessary, have all of the following powers:

- A) To purchase, lease, sell, or otherwise deal in real property, for the purpose of having offices both within and without the State of Idaho.
- B) To purchase, lease, sell, or otherwise deal in personal property of all kinds.
- C) To enter into and perform contracts of every kind, to purchase and own stock of this or other corporations, to conduct any and all businesses which shall or may arise from such objects, to the maximum extent allowable by law.
- D) To purchase and acquire patents, trademarks, trade names or any other intangible objects which may be properly necessary to the conduct of either this or any other lawful business under the laws of the State of Idaho.

- E) To borrow, either directly through banks or other commercial institutions, or indirectly through the issuance of notes, bonds, or other evidence of indebtedness, to the maximum extent allowable by law.
- F) To establish pension and profit sharing plans.
- G) To carry on and conduct any other lawful business as is now or may be permitted by the laws of the State of Idaho.

IV.

This corporation shall have perpetual existence, subject to the provisions for dissolution in the State of Idaho.

V.

The principal place of business shall be Route 5, Twin Falls, Idaho 83301, and the initial registered agent at this address shall be Lawrence I. Golay.


