That SEELEY PROFESSIONAL ASSOCIATION is a corporation duly organized and existing under and by virtue of the laws of the State of Idaho;

That at a Special Meeting of the Board of Directors of SEELEY
PROFESSIONAL ASSOCIATION, held on the 24th day of November, 1975, at
the hour of 8:30 o'clock p.m. of said day, at the Doctor's Lounge,
St. Alphonsus Hospital, Boise, Idaho, at which said meeting a majority
of the Directors of said corporation were present, a Resolution was
