That this corporation is formed for the following objects and purposes to-wit:

"The purpose of this organization shall be to associate young women in personal loyalty to Jesus Christ as Saviour and Lord; to promete growth in Christian character and service through physical, social, mental and spirtual training; and to become a social force for the extension of the Kingdom of God" and to acquire, hold, own, use and dispose of in any manner all real and other property whatsoever as may be reasonably necessary for the purpose of carrying into effect any one or more of the objects hereinbefore mentioned, and to mortgage, sell and otherwise dispose of the same; to borrow money, and to do all acts, and to make, execute and deliver all needful instruments for the carrying on of said purpose or purposes.

The principal place of business of said corporation shall be Boise, Ada County, State of Idaho.

The time for which this corporation shall exist shall be fifty years from and after the date of its incorporation.

This corporation has no capital stock.

-VI-

That the number of directors of this corporation shall be nine.

The Board of Directors shall have the management of the real estate of this corporation and such other management as may be prescribed by the by-laws.

That a duly called meeting of the members of this association was held at its rooms suite No. 408 in the McCarty Building, Boise, Idaho, at the corner of Ninth and Idaho Streets, on Friday the 7th day of February, A. D. 1913, at the hour of 7.30 o'clock P.
