



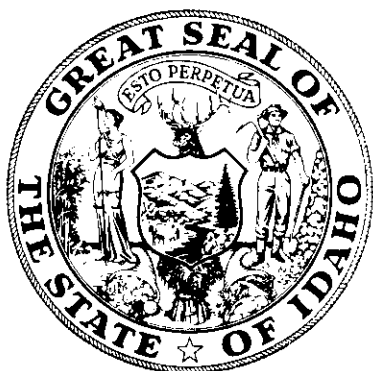
CERTIFICATE OF WITHDRAWAL

Pursuant to Section 30-1-119, Idaho Code, the undersigned corporation, hereby applies for a Certificate of Withdrawal from the State of Idaho and for that purpose submits the following statement:

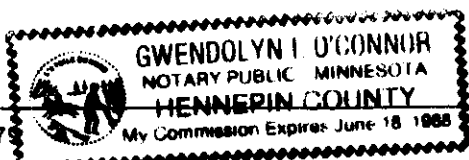
