ARTICLE THREE

PURPOSE CLAUSE

7. This corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

WINDING UP OR DISSOLUTION OF CORPORATION


Upon the winding up or dissolution of this corporation, after paying or adequately providing for the debts and obligations


