### ARTICLES OF AMENDMENT TO THE

#### ARTICLES OF INCORPORATION OF

#### SAGE GYMNASTICS BOOSTER CLUB, INC.

Pursuant to the provisions of Section 30-327 of the Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is SAGE Gymnastics Booster Club, Inc.

SECOND: The following amendment to the Articles of Incorporation was duly adopted by the members of the corporation on April 1, 1981, in the manner prescribed by the Idaho Code.

Article II of the Articles of Incorporation which reads as follows:

## "ARTICLE II PURPOSES

The purposes for which this corporation is organized are to assure active and equitable participation by the parents, guardians and supporters of Sage team members in Sage Gymnastics, Inc.'s programs; to provide additional opportunity for gymnastic training and education in the form of camps, clinics, and/or scholarships; to assist with transportation and housing for Sage team members and visiting gymnasts; to promote fundraising projects to benefit Sage team members: and to assist coaches of Sage Gymnastics, Inc. in their endeavors to improve team members."

shall be deleted and the following substituted therefore.

## "ARTICLE II PURPOSES

This corporation is organized exclusively for charitable or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code."

THIRD: A meeting of members was held on April 1, 1981, a quorum was present at such meeting and the Articles of Amendment set forth above received a majority of the votes which members present at such meeting, in person or by proxy, were entitled to cast.
