## ARTICLES OF INCORPORATION

We, the undersigned / do hereby associate ourselves together for the purpose of forming a corporation under Title 30, Chapter 10, Idaho Code, and adopt the following Articles of Incorporation for such corporation.

## ARTICLE I

NAME: The name of the proposed corporation is IDAHO HORSE RACING SPONSORS ASSOCIATION, INC.

#### ARTICLE II

PURPOSES: The purposes of the corporation are to establish and maintain uniform standards for the sport of horse racing by means of rules and regulations; to aid in the enforcement of said standards; to encourage compliance through the cooperation of sponsors of race meets; to accumulate and disseminate information on horse racing and race meets; to act as an advisory board to settle disputes and grievances at race meets conducted by members; to aid in the development of races for Idaho-bred horses; to aid in establishing positive identification of competing horses; to improve the quality of race meets; to insure uniformity in the conducting of race meets, to aid in the policing of race meets; to encourage enforcement of the racing rules and regulations set forth by the Idaho State Racing Committee; and to aid in the development of horse racing in general.

## ARTICLE III

DURATION: The duration of the corporation shall be perpetual.

#### ARTICLE IV

PRINCIPAL PLACE OF BUSINESS: The location and post office address of the registered office of the corporation in the State of Idaho is the Chamber of Commerce Office, Rupert, Idaho.

## ARTICLE V

MEMBERSHIP: Any individual, firm, corporation or association that conducts horse racing and pari-mutuel wagering is eligible to belong to this association by agreeing to pay the membership fee designated in the bylaws and by agreeing to comply with and be bound by the Articles of Incorporation of the Association, the by-laws and amendments thereto, and such rules and regulations as may from time to time be adopted by the Board of Directors, provided, however, that no individual, firm, corporation or association shall become a member unless and until he or it has been accepted for membership by the Board of Directors or the members. The rights and interests of the members shall be equal and/member can have or aquire a greater interest therein.

## ARTICLE VI

BOARD OF DIRECTORS: The Board of Directors shall be composed of one member from each membership of this corporation.

The Board of Directors may provide for the appointment of such additional officers as they may deem for the best interests of the corporation.

## ARTICLE VII

The corporation formed hereby shall have no capital stock, and shall be composed of members rather than shareholders. This corporation is one which does not contemplate pecuniary gain or profit to the members thereof, and is organized for non-profit purposes.
