BE IT RESOLVED: That Article 7 of the Articles of Incorporation of the Gem State Lumber Company, as heretofore amended, be and the same is hereby amended so that the first paragraph thereof shall read as follows:

The amount of the capital stock of this corporation shall be Six Hundred Thousand Dollars (\$600,000) divided into Six Thousand (6,000) shares of the par value of One Hundred Dollars (\$100,000) per share. Of said capital stock Three Thousand (3000) shares thereof, amounting to Three Hundred Thousand (\$300,000) Dollars shall be common stock and Three Thousand (3,000) shares thereof, amounting to Three Hundred Thousand (\$300,000) Dollars shall be Preferred Stock. From time to time the Preferred Stock and the common stock may be increased according to law, and may be issued in such amounts and proportions as shall be determined by the Board of Directors, and as may be permitted by law, except that in no case and at no time shall the amount of the issued Preferred Stock be in excess of the amount of the issued Common Stock. The holders of Preferred Stock shall not be entitled to vote

said stock and shall have no voice in the business or affairs of the corporation. The capital stock of this corporation shall be non-assessable."
