ARTICLES OF INCORPORATION OF IDAHO TRANSPLANT CENTER, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

 $\underline{\text{FIRST}}$: The name of the corporation is IDAHO TRANSPLANT CENTER, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are for cattle embryo transplants, cattle breeding, the buying, selling, feeding, and dealing in cattle and all forms of livestock, and any and all related purposes, and for transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

<u>FOURTH:</u> The aggregate number of shares which the corporation shall have authority to issue is 25,000 shares; the aggregate par value of the total authorized number of par value shares is \$25,000.00.

FIFTH: In case a stockholder desires to sell his shares of stock, he must first offer them for sale to the remaining stockholders, it being the intention to give them a preference in the purchase of such shares, and any attempted sale in violation of this provision is null and void.

A stockholder desiring to sell his stock shall file notice in writing of his intention with the secretary of the corporation, stating the terms of sale, and unless his terms are accepted by any or all of the other stockholders within ten days thereafter, they shall be deemed to have waived their privilege of purchasing and he will be at liberty to sell to anyone else.

SIXTH: The address of the initial registered office of the corporation is: Route #8, Box 468, Caldwell, Idaho, 83605, and the name of its initial registered agent at such address is: Richard A. LaPointe.
