Dear Ms. Costamagna:

Your letter requesting approval to conduct business in Idaho under the name Banc of America Public Capital Corp. has been received by the Idaho Department of Finance (Department) and has been reviewed by Department staff. Your letter represents that Banc of America Public Capital Corp. is an indirect subsidiary of Bank of America Corporation, a bank holding company, and is a leasing entity originating tax-exampt transactions.

Section 26-1202 of the Idaho Bank Act prohibits any person, other than a national bank, not suthorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. The Idaho Bank Act does not authorize the Director of the Idaho Department of Finance to waive the requirement of the law. Rather, the Department is offering "no objection" to your company's use in Idaho of the name Banc of America Public Capital Corp. Under the circumstances set forth in your letter, we do not believe the name proposed by your company for use in Idaho is misleading to the public. While the Department does not intend to pursue an action under this statute, it is possible that snother agency may do so. However, we believe the likelihood is slight.
