The business, purpose, and object of this corporation is to:

- SECRETARY OF
STATE OF ID
1. Promote the recreation of square and round dancing and other types of dancing.
 2. Promote social activities among the members of the corporation.
 3. Promote public relations and to hold and conduct dancing.
 4. To establish membership requirements in the club.
 5. To establish yearly membership dues and dance entrance fees to cover club operating expenses.
- (b) To carry on all business whatsoever which this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or which may be calculated directly or indirectly to promote the interest of this corporation, or to enhance the value of it's property or business.
- (c) To own real property; to own personal property; to deal in real property; to deal in personal property; to have and to exercise all the powers conferred by the laws of the State of Idaho upon corporations formed under the laws pursuant to and under which this corporation is formed , as such laws are now in effect or may at any time hereafter be enacted.

ARTICLE III

The place where the principle business of the corporations is to be transacted is in the City of Bonners Ferry, County of Boundary, State of Idaho.

ARTICLE IV

The corporation shall be non-stock and no dividends or pecuniary profits shall be declared to the members thereof. The rights and interests of all members shall be equal and no member can have or acquire a greater interest herein than any other member. No membership certificates shall be issued but valid membership in the club shall be established by the By-laws.

ARTICLE V

Officers of the Club and the Board of Directors of the Corporation, one in the same, shall hold office and execute the prescribed duties of the office they hold as set forth in the By-laws.

ARTICLE VI

The period of existence of this corporation shall be perpetual.

ARTICLE VII

Distribution of assets on dissolution of this corporation shall not be inconsistent with the State of Idaho or United States law. The Board of Directors shall present a plan for distribution of all assets to the current members of the club and be voted on by the corporation membership prior to the corporation's dissolution.

ARTICLE VIII

These articles may be amended in any respect at any regular or special meeting of this corporation by a vote of the majority of the quorum attending such meeting provided that the written notice of the proposed amendment or amendments has been mailed to the last known address of each member of the corporation at least ten (10) days prior to the date of such meeting.
