ARTICLES OF INCORPORATION
OF
PANHANDLE SPECIAL NEEDS, INC.
A Non-Profit Corporation

We, the undersigned, being natural citizens of legal age, and being citizens and residents of the United States of America and the State of Idaho, hereby associate ourselves together to form and establish a corporation not for profit under the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation pursuant to the provisions of Title 30-117(a) Idaho Code:

I.

The name of the proposed corporation shall be: PANHANDLE SPECIAL NEEDS, INC.; 302 S. 1st Street; Sandpoint, ID 83864.

II.

The purposes of said corporation are to provide living accommodations for all persons who have a degree of mental retardation; to acquire real estate and personal property of every kind and nature to conduct the same; to enter into agreements to acquire land and to construct living accommodations; to enter into mortgages, leases, and other types of legal instruments necessary to carry out the purposes of this corporation; to apply for Federal or State grants or grants from foundations or any other types of grants which might be received from any individual, association or corporation; to engage in relation thereto with the education, recreation and social and physical activities of any individual who might reside in said living accommodations; to do all things authorized under the provisions of 30-114 Idaho Code; and to do all things necessary to carry out the purposes and intent of this corporation.

III.

This corporation is not for profit and the objects and purposes are purely eleemosynary.

IV.

The corporation shall be non-stock and Certificates of Membership may be issued and each member shall be entitled to a vote and all members shall have equal voting rights.

V.

That the qualifications and conditions of membership shall be fixed by the By-Laws of said corporation and pursuant to the statutes of the State of Idaho as relate to non-profit membership corporations; provided, however, that no person shall be denied membership therein by virtue of race, sex, color or religion.

VI.

The duration of this corporation shall be perpetual.

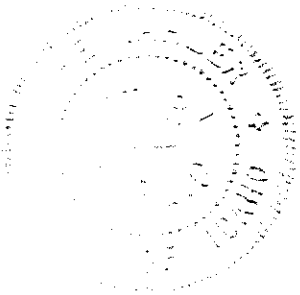
