ARTICLES OF INCORPORATION

of

ROBERT SALAZAR, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is ROBERT SALAZAR, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The corporation is organized for the purpose of owning and managing a retail drugstore and pharmacy and any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is one hundred shares of stock, all of one class, with no par value.

ARTICLE V

Provisions for the regulation of the internal affairs of the corporation shall be set forth in the by-laws of the corporation hereafter to be adopted, which by-laws may from time to time be amended.
